All the District Educational Officers and Project Officers of RVM (SSA) in the state are informed that, this is the 3<sup>rd</sup> year of implementation of Right to Education Act 2009. It is observed from LEP and other national level researches that, the quality in Government schools is not up to the mark. Hence there is a need to focus on quality aspect by providing necessary support.

It is also informed that, during the meeting held by the Hon'ble Minister for Primary Education & SSA with AMOs and CMOs on 29-08-2012 at MCR HRD, Hyderabad it was decided to have one Teacher/Vidya Volunteer for each class to make teaching learning process more effective in Primary Schools where the enrollment is more than 100 to improve quality.

It is further informed that, guidelines were already issued to position Vidya Volunteers in Primary and Upper Primary Schools as per the RTE norms at the commencement of the academic year vide reference 2<sup>nd</sup> read above and the process has already been completed. As per the guidelines, the primary school with enrollment between 101-120 is entitled for only 4 teachers/VVs. The Primary Schools with enrollment more than 121 however will have 5 teachers / Vidya Volunteers as per norms. Hence, one additional Vidya Volunteer is required to position in the primary schools running with an enrollment of 101 to 120 so that all the primary schools having more than 100 and above will have one teacher/Vidya Volunteers for each class.

In view of the above, all the District Educational Officers and Project Officers of RVM (SSA) in the state are requested to make necessary arrangements to position one more additional Vidya Volunteer in the primary schools where the enrollment is between 101 to 120 so as to have one teacher / Vidya Volunteer for each class.
